# Wire Transfer Migration to ISO 20022

## What is ISO 20022?

ISO 20022 is a new global standard for wire transfers, replacing the current format (FAIM) used by the Federal Reserve Banks. This update will improve consistency and compatibility with international systems.

## When is this happening?

The Federal Reserve cutover to ISO 20022 from FAIM is **July 14**, **2025**. All wires sent on or after this date must be in the new ISO format.

### What does this mean for you?

Starting <u>July 14, 2025</u>, all wires sent through the Federal Reserve must use the new ISO 20022 format. This change includes:

- New wire field labels and formats.
- All existing wire templates will be deleted and must be recreated in the new format.

#### Here are some key terminology changes that will take place:

#### **Important Notes:**

Additional address fields are available, including options like Post Box, Department, and Building Name. Review your existing wire templates to prepare for these updates. Verify – Before transmitting any new wires, double-check to ensure accuracy of details in the new format.

#### **How to Prepare Now:**

- 1. Clean Up Templates Review and delete templates you no longer use.
- 2. Mark Your Calendar Plan to log in early on July 14, 2025, to recreate templates and get familiar with the updated fields.

## What to Expect on July 14, 2025?

- Do <u>not</u> transmit any FAIM wires after 3:00pm cutoff time on July 11, 2025. Any pending wires will be deleted.
- Wire templates will not be automatically converted to the new format—you'll need to recreate them.

# Will Sending Wires Look Different?

- Most changes affect field names and labels.
- The process for setting up and sending wires will remain largely the same, but you'll see updated screens and labels.
- We'll handle all behind-the-scenes updates, so you can focus on the visible changes.
